Step 3 of roadmap continues to July 19



Central government outlined a <u>four-step plan</u> below to release England from <u>national</u> <u>lockdown restrictions</u> earlier this year and The Prime Minister confirmed on Monday Step 3 of the roadmap will now remain for a further four weeks to July 19.

It means we continue with the rule up to six people or two households can meet indoors and up to 30 people outdoors with exceptions for weddings, funerals and wakes if social distancing is in place.

Those who can should continue to work from home and all follow 'Hands Face Space Fresh Air'.

Asymptomatic testing sites continue at Cotgrave Hub, adjacent to the Police Station, on Saturdays and Wednesdays and on Bingham market place on Tuesdays and

Fridays until further notice where home testing kits are also available to collect for all over 18s.

The Gotham Road community collect site in East Leake for home testing kits has now ceased with demand being met at local pharmacies for the tests. For further information visit our <u>Community Testing</u> page.

Vaccination appointments now available for over 23s



The local COVID-19 vaccination booking system is currently open to people **aged 23** and **over**.

Eligible residents can book their Covid-19 vaccine by calling 119 or visiting the <u>National</u> <u>Booking Website</u>.

If you live in the Borough, or other parts of Notts, you could take part in a COVID-19 vaccine study through University Hospitals Nottingham.

Volunteers in the study will receive two doses of either a new COVID-19 vaccine or a licensed COVID-19 vaccine in 28 days.

We were due to host a Celebration of Dave Mitchell's life event later this month on June 23.


In line with this week's government roadmap announcement, we are now postponing this to September, in agreement with Dave's family, on a date to be confirmed.

Areas of thunderstorms are expected to move north-eastwards across parts of the country on Wednesday evening and through Thursday.


There is also a further Yellow Thunderstorm Warning valid from 9am on Friday June 18 to 9am on Saturday June 19.


In the following photo, our Mayor Cllr Sue Mallender and Cllr Richard Mallender joined volunteers in Lady Bay for litter picking activities last weekend.

Rushcliffe Country Park's new skate park now open!



Skaters, scooter riders and BMXers are celebrating as Rushcliffe Country Park's new skate park is now open!

We have funded the £210,000 project which was also supported by Skate Nottingham, Canvas Spaces, and VIA East Midlands.

It has been praised as another landmark facility in the county as a street course which has been designed to blend into a country park setting that can meet the needs of future Olympic skateboarders and BMXers whilst being inclusive to beginner riders and the differently abled.


Representatives from each organisation gathered on Friday (June 11) to open the park and test out the new features before a grand opening event is planned later this summer when COVID restrictions allow.

The facility replaced the former wooden structure which was in need of refurbishment and we developed the project alongside Skate Nottingham, science education charity Ignite! Futures and Nottingham Trent University.

They involved 110 young people in co-designing the new facility through a series of workshops and by work experience during the construction phase.

County power station sites reach next stage in world-leading fusion energy plant



Two existing Nottinghamshire coal-fired power station sites have made the initial shortlist as part of the national search to find potential sites to design and build what is hoped to be the world's prototype fusion energy plant by 2040.

It forms part of the UK's bid to be the first to develop a commercial power station that will use the energy produced by fusion reactions to generate electricity. Fusion offers an inherently safe and virtually limitless source of clean electricity by copying the processes that power the sun.

Two existing coal-fired power stations in Nottinghamshire in the running to host what is hoped to be the world's first prototype fusion energy plant, have made it to the next stage.

Part of the site at Ratcliffe-on-soar and West Burton A, near Retford, have both made it to the final 15 sites as part of a national search for potential locations by the government for alternative energy plants.

The UK Government is bidding to be the first to develop a commercial power station that will use the energy produced by fusion reactions to generate electricity. Fusion offers an inherently safe and virtually limitless source of clean electricity by copying the processes that power the sun.

The ambitious project - Spherical Tokamak for Energy Production - known as STEP, is being led by the UK Atomic Energy Authority (UKAEA).

Shortlist for award for speed of grant distribution



Our Finance and Revenue teams have been shortlisted for a national award highlighting the brilliant way they have joined forces during COVID to distribute vital central government funds to local businesses.


A submission for the CCLA/Room151 Impact Award has been successful after the great work by the teams over the last 15 months that saw thousands of the grants administered with speed and accuracy.

Our 151 Officer and Deputy Chief Executive Peter Linfield, Finance Service Manager Sarah Whittaker and Revenues Manager Rob Cottee were key to developing a scheme across the Borough which enabled the grants to be distributed as soon as funds were made available.

It involved a pressured challenge to quickly identify appropriate criteria, create a secure method to identify eligible applicants and notify them that they could claim and receive the vital funds they needed to help them stay afloat.

Have your say on further control of dog fouling



We are proposing to update our legislation around dog control and dog fouling.

This will introduce a Public Spaces Protection Order (PSPO) targeted at the control of dogs and dog fouling across the borough and/or for specific associated controls in defined parts of the Borough.

We already have PSPOs for other purposes and this proposal will replace any existing historic laws and/or orders around dog control, bringing the rules in this area up to date, expanding controls and enabling the rules to apply to areas that have recently been subject to development, which currently aren't covered fully.

A PSPO can be used Borough wide or in a defined area to tackle specific behaviours of the dog's keeper that is detrimental to the local community's quality of life. This is done by imposing conditions on the use of that area which apply to everyone in control of a dog. Under the new proposal it is intended that the Schedule 1 option of the Order will be Borough wide and within all open-air spaces in the Borough that are accessible to the public:

- a) Persons in charge of a dog must remove the faeces and for it to be disposed of in an appropriate receptacle
- b) Persons in charge of a dog must have with them appropriate means to pick up dog faeces deposited by that dog
- c) Persons in charge of a dog must, when requested by an authorised officer of the Authority produce evidence of a means to pick up dog faeces deposited by that dog

Enforcement focus will be on those areas that the impact of dog fouling has on other members of the community. We would welcome your views as to specific locations that you feel should be covered by the proposed PSPO and whether you support the proposals or if you have any further comments in general.

As part of the PSPO process it is also necessary to provide evidence of the impact and the need for the PSPO restrictions. If you have any records showing a regular fouling spot or concerns about dogs off leads, then please also supply this information also.

A full public consultation on these proposals and the PSPO will require further approval before being implemented and may change following this consultation.

In addition, the enforcement of the PSPO rules will be through the issuing of a fixed penalty notice by an authorised officer or the police, which if not paid can lead to prosecution in the Magistrates Courts'. The amount will be subject to public consultation but currently is set at £100 and reduced to £75 for dog fouling.

Reach Rushcliffe fund further expanded to tackle loneliness and isolation



We have further extended our Reach Rushcliffe fund, dedicated to supporting projects across the Borough that tackle loneliness and isolation.

Being connected with other people matters for everyone's health and COVID-19 has further highlighted how social isolation can be bad for our mental and physical health.

It's fast becoming one of the greatest social challenges nationally and whilst often associated with older people who live on their own, it can affect anyone of any age and linked to issues such as obesity, smoking and can increase risk of dementia.

Projects should aim to take steps to make contact and engage individuals or groups in Rushcliffe communities who may have little or no social contact.

This could be initiatives based around a structured befriending initiative to check on individuals, lunch clubs, or safe regular social meet up events in line with government advice or other projects.

Have your say on electoral wards in the Borough



A reminder the Local Government Boundary Commission for England (LGBCE) has launched a public consultation inviting proposals to maintain the current pattern of electoral wards for the Borough.

This includes their recommendation that 44 councillors should be elected to the Council in future instead of our previous proposal to the authority it could increase to 46 in line with our increasing populations.

They are inviting proposals from the council, interested parties and members of the public until July 19, 2021 and you can have your say on the LGBCE website which contains links to guidance and maps of the current wards.

The Commission recently gave a briefing designed to inform a wider group of stakeholders about the current position and gain a better understanding of our

communities' make-up. You can watch the <u>video</u> or if you wish to request a copy of the slides, please email media@rushcliffe.gov.uk.

It included questions on how ward boundaries can be altered and the restrictions around them and also how the names of new wards and parishes need to have a historical link should any be created.

Views on the consultation can also be submitted by email to reviews@lgbce.org.uk.

They plan to publish proposals for new electoral arrangements in October with further consultation planned between then and December and intend to publish final recommendations in March 2022.

Parliamentary constituencies review



The Boundary Commission for England has recently published its initial recommendations for the new parliamentary boundaries to be introduced for the next Parliamentary Election due to take place.

For residents of Rushcliffe there is very little change with Barnstone Parish proposed to move from Rushcliffe Constituency to Newark Constituency which would then make all of Thoroton Ward in Newark Constituency.

Shelford and Newton Parishes are also proposed to move from Rushcliffe Constituency to Newark Constituency which would then make all of East Bridgford ward in Newark Constituency.

Therefore the proposals make perfect sense to realign the boundaries so that 20 full wards would be in Rushcliffe Constituency and five full wards (Bingham East, Bingham West, Cranmer, East Bridgford and Thoroton) would be in Newark constituency. Obviously this is based on the current wards and not on what they may look like by 2023 following the Ward Boundary Review.

View the <u>Rushcliffe map</u> and <u>Newark map</u> will now be a period of consultation on the initial recommendations which closes on August 2.

The further stages to the process are below:

- Early 2022: Publish responses to initial proposals and conduct six-week 'secondary consultation', including between two and five public hearings in each region;
- Late 2022: Publish revised proposals and conduct four-week written consultation;
- June 2023: Submit and publish final report and recommendations.


D lock loan available at Rushcliffe Arena
